In addition, you are permitted to play golf on the Weekends by using a round of golf from your Membership and paying a \$10 surcharge the day of for any games played between Open until Twilight. After Twilight on Weekends you are permitted to play & deduct 1 game for 18 holes, & permitted to play at Double Twilight when a ½ game will be deducted, both times with no additional surcharge.
